

What is INLEXZO™?

INLEXZO™ (gemcitabine intravesical system) is a prescription medicine for the treatment of adults with a type of cancer of the lining of the bladder called non-muscle invasive bladder cancer (NMIBC), that has not spread to other parts of the body, and that did not respond to treatment with Bacillus Calmette-Guérin (BCG).

Males treated with INLEXZO™:


o If you have a female partner who is able to become pregnant, you should use effective birth control (contraception) during treatment with INLEXZOTM and for 3 months after final removal of INLEXZOTM.

MEET THE PRETZEL BY INLEXZO™

INLEXZO™ is an innovative treatment delivery system for adults who have certain types of non-muscle invasive bladder cancer (NMIBC) when Bacillus Calmette-Guérin (BCG) stops working. It is a thin, flexible, curled silicone tube, shaped similar to a pretzel, which contains cancer-fighting medicine called gemcitabine.

- A thin, flexible, curled silicone tube
- Designed to release a cancer-fighting medicine into the bladder overtime
- Administered by a healthcare provider during a brief office procedure through a urinary catheter
- Stays in the bladder for about 3 weeks at a time




THE INLEXZO™ DOSING SCHEDULE

Each dose of INLEXZO™ stays in the bladder for about 3 weeks at a time.

INLEXZO™ is given in 14 doses over about 2 years


• INLEXZO™ is inserted into the bladder once every 3 weeks for up to 6 months (8 doses), and then once every 12 weeks for up to 18 months (6 doses)



Continuation Period

Next 18 months





Dosing is quarterly after 6 months

THINGS TO KNOW DURING TREATMENT

INSTRUCTIONS FOR YOUR LOVED ONE:

② BEFORE RECEIVING INLEXZO™

Do not empty their bladder right before INLEXZO™ insertion procedure

② AFTER RECEIVING INLEXZO™

- Drink about 6 to 7 cups (1500 mL) of fluids per day during treatment with INLEXZO™ to make sure they produce enough urine for the medicine to be released into the bladder
- Your loved one can urinate normally. There is no need for them to hold their urine
- Avoid contact between their skin and urine
- To urinate, males and females should sit on the toilet and flush after each use
- Wash their hands with soap and water and wash their genital area with water after each time they urinate
- Wash clothing soiled with urine right away and separately from other clothing

1 AFTER THE HEALTHCARE PROVIDER REMOVES INLEXZO™

 Avoid contact between their skin and urine for at least 24 hours after INLEXZO™ is removed

MAGNETIC RESONANCE IMAGING (MRI) SAFETY INFORMATION CARD

Your loved one's healthcare provider will give them a Magnetic Resonance Imaging (MRI) Safety Information Card.

 Show it to their healthcare providers, who will determine the conditions in which they can safely do an MRI scan if needed while INLEXZO™ is in their bladder



TREATMENT DAY CHECKLIST

Caregiving can feel overwhelming at times. Beyond the concern for your loved one, there are a lot of other things to manage. This checklist can help you prepare for treatment days.



Make a schedule

Knowing where the treatment takes place and when your loved one needs to be there can help make the day smoother.



Help your loved one feel comfortable

Even small things, like encouraging them to wear comfortable clothes and bringing snacks, can help. Always talk with their care team about snacks or drinks to make sure they won't impact the treatment.



Adjust your schedule

Treatment days can disrupt your usual schedule. It helps to block out time in advance—and to let your friends, family, and coworkers know if you need help with any errands while you're helping your loved one.

Remember, if your loved one misses an appointment, be sure to schedule another one as soon as possible.

 are breastfeeding, or plan to breastfeed. It is not known if INLEXZO™ passes into your breastmilk. Do not breastfeed during treatment with INLEXZO™ and for 1 week after final removal of INLEXZO™.

Tell your healthcare provider about all the medicines you take, including prescription and over-the-counter medicines, vitamins, and herbal supplements.

POSSIBLE SIDE EFFECTS WHILE TAKING INLEXZO™

As with any treatment, side effects can occur. Taking notes of which ones your loved one experiences, when they occur, and how often can help at the next doctor appointment.

Most common bladder-related side effects include:



Frequent need to pass urine more often than usual



Urinary tract infection



Pain or burning sensation when passing urine



Urgent need to pass urine



Pain in the urinary tract (felt in the lower stomach area or lower back)



Blood in urine



Bladder irritation

Most common blood test-related side effects include:



- Decreases in blood cell counts (hemoglobin, white blood cells)
- Changes in pancreas function blood tests (increased lipase)
- Increased potassium level in the blood
- Changes in kidney function blood tests (increased creatinine)
- Changes in liver function blood tests (increased aspartate aminotransferase, increased alanine transaminase)
- Decreased sodium level in the blood

These are not all the possible side effects, and they can vary from person to person

In a clinical study of 85 people with certain NMIBC that did not respond to BCG, 7% of people permanently stopped INLEXZO™ treatment due to side effects.



DAY-TO-DAY CARE



Ask your loved one how they're feeling

Taking notes on how their treatment is going and which side effects they may experience will help when talking with their healthcare provider.



Watch for signs of infection

One of the potential side effects while being treated with INLEXZOTM are urinary tract infections. Keep an eye out for certain signs, such as a fever. If you suspect your loved one may have a urinary tract infection, contact their healthcare provider immediately. Your loved one's healthcare provider may give them antibiotics before INLEXZOTM is inserted or removed.



Set goals to stay hydrated

While INLEXZO™ is in the bladder, your loved one should drink plenty of non-alcoholic, caffeine-free fluids (at least 1500 mL or 6-7 cups per day). This helps produce urine in the bladder so that INLEXZO™ can work properly.

DON'T FORGET TO TAKE CARE OF YOURSELF

While you want to do everything you can to help your loved one—it can sometimes feel overwhelming. It helps to practice self-care along the way.

How will I receive INLEXZO™?

- INLEXZO™ will be inserted and removed by your healthcare provider.
- INLEXZO™ is inserted into your bladder through a tube called a urinary catheter 1 time every 3 weeks for up to 6 months (8 doses) and then 1 time every 12 weeks for up to 18 months (6 doses).
- INLEXZO™ is removed after 3 weeks of being inserted (3-week indwelling period).
- Your healthcare provider will decide how many INLEXZO $^{\text{TM}}$ treatments you will receive.

Before receiving INLEXZO™:

• Do not empty your bladder right before your procedure to insert INLEXZO™.

After receiving INLEXZO™:

- Drink about 6 to 7 cups (1500 mL) of fluids per day during treatment with INLEXZO™ to make sure you produce enough urine for the medicine to be released into the bladder.
- You can urinate normally. There is no need to hold your urine.

- · Avoid contact between your skin and urine.
- To urinate, males and females should sit on the toilet and flush after each use.
- Wash your hands with soap and water and wash your genital area with water after each time you urinate.
- · Wash clothing soiled with urine right away and separately from other clothing.

After your healthcare provider removes INLEXZO™:

Avoid contact between your skin and urine for at least 24 hours after INLEXZO™ is removed.

What should I avoid after INLEXZO™ is inserted?

Tell your healthcare provider that you have INLEXZO™ before having a type of scan called Magnetic Resonance Imaging (MRI).

INLEXZO™ may be used under specific conditions. Your healthcare provider will give you an MRI Safety Information Card. Keep the card in a safe place and show it to all of your healthcare providers. The card contains important information in case you need to have an MRI. Your healthcare provider will review the information on the MRI Safety Information Card and determine the conditions they can safely do an MRI scan while INLEXZO™ is in your bladder.

What are the possible side effects of INLEXZO™? The most common side effects of INLEXZO™ include:

- frequent need to pass urine more often than usual
- urinary tract infection
- pain or burning sensation when passing urine
- urgent need to pass urine
- decreased hemoglobin
- increased lipase
- pain in the urinary tract (felt in the lower stomach area or lower back)

- decreased lymphocytes
- blood in urine
- increased creatinine
- · increased potassium
- increased aspartate aminotransferase
- decreased sodium
- bladder irritation
- increased alanine transaminase

INLEXZOTM may cause fertility problems in males, which may affect your ability to have children. It is unknown if these side effects of fertility are reversible. Talk to your healthcare provider if this is a problem for you.

Tell your healthcare provider if you have any side effect that bothers you or does not go away.

These are not all the possible side effects of INLEXZO™.

What are the ingredients in INLEXZO™?

Active ingredient: gemcitabine hydrochloride

Inactive ingredients for gemcitabine component: polyethylene glycol 8000, povidone K30, and urea.

Inactive ingredients for osmotic components: FD&C Blue No.1, polyethylene oxide 600,000, and urea.


